TO APPLY, THE FOLLOWING IS REQUIRED:

- ❖ Each person 18 and over must fill out a complete application.
- ❖ *Note: Properties will not be held for long periods of time.*
- ❖ All applications must be filled out, initialed on 1st page, & signed by the applicant on application's 2nd page.
- ❖ A \$35.00 processing fee (cash, cashier's check or money order) must accompany this application for each adult, 18 and older. **No application will be processed without a processing fee.**
- ❖ **Reliable documentation for your income is required.** Income should be approx. 3 times 1 month's rent.
- ❖ All intended residents MUST be listed below. The second page of the application must be completed.
- ❖ ALL pets of any size, kind or type must be disclosed.
- ❖ All vehicles of any size, kind or type must be disclosed.
- ❖ Water filled furniture must be disclosed on this application.

THE APPLICANT IS HEREBY NOTIFIED OF THE FOLLOWING PROCEDURES & POLICIES:

- ❖ Applicants must have current identification in the form of driver's license, state ID, military ID, or passport.
- ❖ **If approved, the first month's rent, total security deposit, advance and/or last month rent, non refundable pet fee (if applicable) & \$35 Lease Preparation fee must be paid in full with certified funds (cashier's check or money order) prior to renting & all persons 18 and over must sign a rental agreement.**
- ❖ Qualifying is based on income, credit, landlord history and/or home ownership. Written and verifiable documentation must be supplied for income; W-2's for employment, tax returns or any documentation that proves income. (Please ask if you are unsure).
- ❖ Any false information given can be a reason for denial of an application.
- ❖ Applications are generally processed in 2-4 business days, but applications can take longer if information is needed from the applicant or a reference for the applicant.
- ❖ The processing fee is NON-REFUNDABLE, if application is processed.
- ❖ Salefish Properties and/or the owner must approve all pets, and IF a pet is allowed, a pet fee is required (minimum of \$300 & nonrefundable). An increase in deposit, determined by the owner of the property, may be required for ALL DOGS & CATS, WHETHER THEY ARE AN "INSIDE" OR "OUTSIDE" ANIMAL. Pet records are required, if your application is approved. Refer to the *Salefish Properties* Pet Policy for more information.
- ❖ If there is water filled furniture, an insurance policy must be supplied within ten (10) business days.
- ❖ To hold a property & refuse other applicants, the **security deposit** must be paid and a lease signed.
- ❖ A driver's license, military ID, state ID or current passport is required when submitting this application. If approved, vehicle registration will be needed prior to lease signing, photo ID is required at lease signing.
- ❖ If tenant is approved, a walk-through Property Condition Survey is to be signed prior to occupancy.
- ❖ **HOUSING DEPOSIT AGREEMENT** – Applicant has provided a "**HOUSING DEPOSIT**" of \$_____ in consideration for taking the dwelling off the market while the application is being processed. If applicant is approved and lease is entered into and possession of the apartment is taken the "**HOUSING DEPOSIT**" **shall be applied toward the security deposit.** If applicant is approved, but fails to enter into the lease within 3 days of written approval, unless otherwise negotiated in writing, and/or fails to take possession after lease signing, the **FULL "HOUSING DEPOSIT"** shall be forfeited to the Landlord and/or Management. The "**HOUSING DEPOSIT**" shall be refunded only if applicant is not approved. This application is preliminary only, in no way implies that the desired rental unit shall be available and in no way obligates Landlord and/or Management to execute a lease or deliver possession of the proposed premises.
